MEMBERSHIP CLASSIFICATION AND DUES

NEW MEMBER APPLICATION

VOTING: Each Auctioneer Member who has paid dues and is otherwise in good standing shall have One (1) vote upon each matter submitted to a vote at any meeting of the Corporation, Annual or Special. Each Auction Company member shall have One Vote at any meeting of the Corporation, Annual, or Special. The vote of an Auction Company CANNOT be cast by a voting Auctioneer Member from his/her Auction Company. A Member shall only have One (1) vote.

- ACTIVE AUCTIONEER MEMBERS:** members shall be those presently licensed to conduct auctions in the State of Utah. Active Auctioneer Member shall be entitled to one (1) vote.
- AUCTION COMPANY MEMBERS:** Auction Company OWNERS shall be those auction companies presently licensed to conduct auctions in the State of Utah. Auction Company Owners shall be entitled to one (1) vote.
- ASSOCIATE MEMBERS:** Individuals who are not auctioneers but who are involved in auction or auction-related businesses, I.E., Ring Person, Clerks, and Cashiers. **NO VOTING RIGHTS**
- TRADE MEMBER:** Trade members shall be those persons, firms or corporations engaged in any related business or business endeavor having a relationship of a general nature with the business conducted by auctioneer members. **Shall NOT be entitled to vote on any matters, except as may otherwise be required by law.**
- HONORARY MEMBER:** Honorary membership may be granted by the Board of Directors to members and non-members in recognition of any outstanding service rendered for or in behalf of this corporation or the auction profession. Honorary members shall not be required to pay dues. **Shall NOT be entitled to vote UNLESS he/she is a member in good standing.**
